An Act to amend the Customs Tariff Ordinance

[6TH FEBRUARY, 1963]

ENACTED by the Parliament of Tanganyika.

1. This Act may be cited as the Customs Tariff Ordinance Short title, (Amendment) Act, 1963, shall be read as one with the Customs and Tariff Ordinance, and shall be deemed to have come into operation on commencethe sixth day of February, 1963.

2. Section 3 of the Customs Tariff Ordinance is hereby amended by Section 3 of Cap. 346 adding the following new subsection:-

"(4) Notwithstanding the provisions of subsection (1), where any imported crude or partly refined petroleum is removed for refining to a refinery licensed as a bonded warehouse, the import duties and suspended duties on such petroleum shall instead of being charged on the importation of that petroleum, be charged on the delivery of any goods from the refinery for home consumption and shall be the same as those which would be payable on the importation of like goods.".

3. The First Schedule to the Customs Tariff Ordinance is hereby First Schedule to Cap. 346 amended as follows:-
