An Act to amend the Exchequer and Audit Ordinance, 1961, the Appropriation Act, 1962, and the Supplementary Appropriation (1962-1963) Act, 1962

[12TH DECEMBER, 1962]

ENACTED by the Parliament of Tanganyika.

1. This Act may be cited as the Revenue Laws (Miscellaneous Provisions) Act, 1962. Short title

PART I

AMENDMENT OF THE EXCHEQUER AND AUDIT ORDINANCE, 1961

2. This Part shall be read as one with the Exchequer and Audit Ordinance, 1961 (hereafter in this Part referred to as the Ordinance).

3.-(1) Section 13 of the Ordinance is hereby amended by deleting from the second line of subsection (1) thereof the word "Minister" and substituting therefor the word "President".

(2) This section shall come into operation on the ninth day of December, 1962.

4.-(1) The Ordinance is hereby amended by inserting immediately after section 14 thereof the following new section to be numbered 14A:-

"Interpretation of certain reference

14A. The reference to a bank in section 8, in subsection (2) of section 12 and in subsection (3) of section 13 shall be deemed to include a reference to the Crown Agents, and the reference to a bank account in section 14 shall be deemed to include a reference to the Joint Consolidated Fund administered by the Crown Agents."

(2) This section shall be deemed to have come into operation on the first day of July, 1961.

5. Section 26 of the Ordinance is hereby amended as follows:-

- (a) in the proviso to paragraph (a) of subsection (1) thereof, by deleting the words and symbols "sub-paragraphs (iii) and (iv)" and substituting therefor the words and symbols "sub-paragraphs (iii), (iv), (vi) and (viii)"; and
- (b) in subsection (2) thereof, by inserting immediately after the words "four months" in the first line the words and symbols "(or such longer period as the National Assembly may by resolution appoint)".
