An Act to amend the Local Government Election (Urban Areas) **Ordinance**

[13TH JULY, 1962]

ENACTED by the Parliament of Tanganyika.

- 1. This Act may be cited as the Local Government Election (Urban Short title Areas) Ordinance (Amendment) Act, 1962, and shall be read as one and construction with the Local Government Election (Urban Areas) Ordinance (herein-Cap. 379 after called the Ordinance).
- 2. Section 30 of the Ordinance is hereby amended by deleting the Section 30 word "fourteen" in the fourth line thereof and substituting therefor of Cap. 379 the word "eighteen".
- 3. Section 42 of the Ordinance is hereby amended by deleting the Section 42 word "twelve" in the fourth line of subsection (2) thereof and substituting of Cap. 379 therefor the words and symbol "twenty-six".
 - 4. The First Schedule to the Ordinance is hereby amended—

(a) by deleting the Form A contained therein and substituting therefor the following new Form A:—
