An Act	to amend	the Coffee	Industry	Ordin	ance	٦

ENACTED by the Parliament of the United Republic of Tanzania.

1. This Act may be cited as the Coffee Industry Ordinance (Amend-Short title, ment) Act, 1965, shall be read as one with the Coffee Industry Ordinance and com-(hereinafter referred to as "the Ordinance"), and shall come into opera-mencement tion upon such date as the Minister for Commerce and Co-operatives cap. 438 shall, by notice in the Gazette, appoint.

- 2. Section 2 of the Ordinance is hereby amended by deleting the Section 2 of definition "Minister" and by substituting therefor the following new Cap. 438 amended definition:—
- " 'the Minister' means the Minister for the time being responsible for commerce;".
- 3. Section 6 of the Ordinance is hereby amended by deleting the words, Section 6 of figure and brackets "section 8 of the African Agricultural Products Cap. 438 (Control and Marketing) Ordinance", in paragraph (c) (i) of subsection (2), and by substituting therefor the words, figures and brackets "section 7 of the Agricultural Products (Control and Marketing) Act, 1962".
- 4. Section 7 of the Ordinance is hereby amended by deleting the Section 7 of words, figure and brackets "section 8 of the African Agricultural Cap. 438 Products (Control and Marketing) Ordinance", in subsection (1), and amended by substituting therefor the words, figures and brackets "section 7 of the Agricultural Products (Control and Marketing) Act, 1962".
- 5. Section 15 of the Ordinance is hereby repealed and replaced by Section 15 of the following new section:—

  by Section 15 of Cap. 438 replaced

"Imposition of levy

- 15.—(1) It shall be lawful for the Board, with the prior approval of the Minister and by order published in the Gazette, to impose a levy on all or any description of coffee grown in Tanganyika.
- (2) Without prejudice to any other means of distinguishing different descriptions of coffee grown in Tanganyika, coffee may be distinguished for the purposes of this section by reference to any dealing therewith or use thereof or by the destination to which it is consigned, and different rates may be prescribed for different descriptions.
- (3) The levy imposed under this section shall be collected in such manner as may be prescribed.".

Section 16 of Cap. 438 amended

- 6. Subsection (4) of section 16 of the Ordinance is hereby amended as follows:—
  - (a) by deleting the words and commas "less, in either case, a sum equal to the levy for which such coffee would have been liable had it been exported and had not been purchased by the Board," and by substituting therefor the words and commas "less, in either such case, a sum equal to any levy for which such coffee may become liable";
  - (b) by deleting the full stop at the end of the subsection, substituting therefor a colon, and by adding the following new proviso:—

"Provided that if any coffee so purchased does not become liable for a levy imposed under this Ordinance, any sum deducted in respect of levy under this subsection shall be repaid to the vendor by the Board."
